Instruction for Course & Exam Registration:

- 1. First Department will complete the Course Registration activity till 38th July 2023 and thereafter student will complete exam registration activity (till 31st July 2023 (Midnight)) in the schedule time through their own login ID. Then student will confirm the printout receipt of exam registration with the signature of the Department Exam Coordinator / HOD. All the concerned students must follow all these procedure carefully.
- 2. Detained students will pay Rs 1000/- per course for the course registration of detained subjects. Then he has to pay exam fees and complete the activity as mentioned in above instruction 1.
- 3. Due to non-availability of **Old MIS server**, P02, P-07, P-11, P-16 & P-18 scheme students will complete their course and exam registration by submitting manual form to their respective Departments.
